Illinois Terrorism Task Force (ITTF) - Chairs Meeting - May 28, 2014 - 10:00 a.m. Held at the Illinois Emergency Management Agency (IEMA)

ITTF Administrative Update

Chairman Kauerauf expressed his appreciation to all committee chairs and members for working on the 2014 Budget. The 2014 Budget application was submitted on May 17, 2014. The 2014 Emergency Management Performance Grant Award has been received. He has received notification that the House Appropriations Committee released its proposed fiscal year (FY) 2015 Department of Homeland Security (DHS) Appropriations bill, which continues to support level funding. We anticipate the FY 2015 grant guidance will be provided by October 1, 2014.

Chairman Kauerauf and the Committee Chairs discussed the FY 14 budget process. The following comments were noted for future budget discussion and application submission:

- Recommend connecting the projects with the strategic visions.
- Look at strategic goals/objectives that fit within the projects.
- Have the State Administrative Agency inform the Chairs of what goals are being discussed on the front end (DHS, NEMA, etc.)
- Form a small advisory group working with the SAA to first discuss the priorities, and then push out to the membership.
- Continue to use the THIRA as one of the tools/equation for the budget process.
- Use the "recovery response" plan before, after, incident.
- The Communications Committee in the past has done a lot of "planning" and continues, but has become more of a "communications strategic technology reserve maintenance group." The concern was expressed that this is applying to the other committees. We need to strategically decide are we going to continue to make this into a maintenance program vs an expansion program? What are the priorities for the "strategic technology reserve" and how do they fit into the strategy?

Old Business

ITTF Policies

Chairman Kauerauf discussed the following ITTF Policies changes:

- ITTF Policy Statement 2014 (2) Regarding Use of Federal Preparedness Training Funds
 - Starting with FY 13 and 14 grant funds, when training (FEMA definition) is conducted, Grantees no longer have to submit web forms through the first responder.gov portal with DHS.
- ITTF Policy Statement 2014 (3) Regarding Meals Provided for Homeland Security Training/Exercise, Sessions, Meetings or Conference
 - Lunch and, under very limited circumstances, breakfast or dinner may be provided to participants at training sessions, meetings, or conferences that are allowable activities budgeted by the sub-recipient under applicable federal preparedness guidelines. Approval from the ITTF Chair or his/her designee must be requested via email or other written communication prior to the event.

Conference Workgroup

Chairman Kauerauf discussed the formation of a conference workgroup to discuss the need for policy and standards. If a committee receives grant funds for conferences, they must participate in the workgroup in order to continue to receive FY 14 funds. Other committee members are welcome to participate, also.

Illinois School Security Grant Program Update

Chairman Kauerauf provided an update on the Illinois School Security Grant Program. The grant application review process was completed, and announcement of the grant award occurred May 1, 2014. The program awarded 448 grants to various schools and campuses throughout Illinois. The schools are now accepting or declining the awards, as not all projects that were submitted were funded. Grant agreements will be sent out to the schools that accepted the grant.

Capstone 14 Exercise Update

As previously discussed at ITTF meetings, the Capstone Exercise will be held June 16-20, 2014. On Friday, June 20th a "recovery exercise" will be held at IEMA. Chairman Kauerauf encouraged any ITTF member to participate in this session to discuss short, intermediate, and long term recovery efforts from a catastrophic earthquake.

FFY 14 Homeland Security Grant Program and Capital Replacement Program Update

Michelle Hanneken, Grants and Policy Manager, provided an update of the submission of the FFY 14 Homeland Security Grant Program. The grant application was submitted to FEMA on May 17, 2014, with the anticipated receipt of the grant award in the fall. She also discussed the Capital Replacement Program. As of today, we have had funds returned to us, and we have started the process to fund the items on the approved Capital Replacement Requests list. We will continue to go down the list as more funds are returned.
