Minutes

Homeland Security Updates

Homeland Security Advisor/IEMA-OHS Director Alicia Tate-Nadeau outlined the reduction in federal homeland security funding for $FFY24 - a\ 10\%$ cut for Illinois.

Chief Intelligence Officer Aaron Kustermann, Illinois State Police State Terrorism and Intelligence Center, provided an intelligence briefing.

Jennifer Rominger, Security Program Manager, Department of Innovation and Technology, provided a cybersecurity briefing.

Old Business

• Discussion of FFY24 Homeland Security Grant Program (HSGP) project submission recommendation from Council of Chairs:

Chairman Page summarized the recommended projects, most of which reflected cuts. Page pointed out the challenge of considering the funding minimums (3% for election security and 30% for law enforcement), spending caps for personnel, state/local splits, and core mission areas when formulating the budget. He explained how some items being cut could be moved to the state Preparedness and Response (PAR) grant – specifically, capital replacement, equipment that's not on the federal AEL list, and operational costs for response for personnel paid with preparedness funds – keeping in mind not all equipment can be moved off federal grants because of the personnel spending cap.

Page thanked applicant organizations for their cooperation in adjusting their budget requests after the extent of Illinois' reduced funding was known. Page and Evans pointed out that the FFY 24 performance period starts July 2025 – and that the following open grants are in progress: FFY 21 (extended by FEMA, with an expiration date of July 2025), FFY 22, and FFY 23. Starting in September 2024, the reallocation process for any returned funds will begin, with a focus on items from the prioritized unmet needs list.

Discussion took place on the impacts of the funding reduction on grant recipients.

• Motion to approve FFY24 HSGP project submissions.

Motion to approve: Dave Christensen, McHenry Co. EMA Seconded: Joe Holomy, IFCA Voice roll call vote was conducted. Motion passed.

New Business

• Discussion of SFY 25 Preparedness and Response (PAR) grants:

Bob Evans, IEMA-OHS Division of Preparedness and Grants Administration, explained that it will not be known until the final state budget is approved – likely at the end of May – if the PAR grant request for \$7.5 million will be awarded. Depending on the final allocation received, any necessary adjustments/reprioritizations of budgeted projects will be made at the next Council of Chairs meeting. The SFY 25 PAR period of performance will run from July 1, 2024, to June 30, 2025.

Chairman Page explained that the HSAC also has a version of proposed PAR projects totaling \$5 million, in the event the \$7.5 million request is not approved.

Following Chairman Jim Page's retirement April 30, all HSAC inquiries can be directed to IEMA-OHS Deputy Director of Homeland Security Claire Moravec until a replacement is named.
