➤ **State Homeland Security Updates**

- IEMA-OHS Acting Director Berger expressed gratitude for partners with which to engage in dialogue and share updates in order to continue serving residents and delivering services.

Director Berger also spoke about the homeland security enterprise in Illinois and looking at ways in the days ahead to make the HSAC even more effective, impactful and resilient.

- Deputy Director Windisch expressed appreciation for the opportunity to hear feedback from community stakeholders. She said the feedback from emergency management and homeland security partners has been valuable as they have shared their plans, perspective and priorities.
- Chief Evans reminded the group about the 2025 annual report due to the governor March 1, 2026, and said guidance on committee input would be outlined at the December Council of Chairs meeting.

- Evans introduced two new committee chairs: Robert (Bobby) Van Bebber, IDPH, Public Health Committee and Clayton Kuetemeyer, IEMA-OHS, Emergency Management Committee.
- Evans shared that the one-year extension request for FFY23 HSGP was approved. The grant will now expire August 31, 2027.
- Discussion of prioritization of unmet needs projects for FFY22 Homeland Security Grant Program (HSGP) and SFY26 Preparedness and Response (PAR) grant program: Organizations briefly described their proposed projects. Evans shared information provided by the city of Chicago. Project list is attached to minutes.
