Dear Ms. Schultz:

This SECOND NOTICE is for the Illinois Emergency Management Agency and Office of Homeland Security's Proposed Rule pertaining to State Not-For-Profit Security Grant Program.

In compliance with Section 220.500 of the Operational Rules of the Joint Committee on Administrative Rules, the Illinois Emergency Agency and Office of Homeland Security states as follows:

- 1) The name of the agency is the Illinois Emergency Management Agency and Office of Homeland Security.
- 2) The title of the Proposed Rule is State Not-For-Profit Security Grant Program 29 Ill. Adm. Code 120.
- 3) The First Notice Period began March 29, 2024, with the publication of Vol. 48, Issue 13 of the Illinois Register, beginning at p.4525.
- 4) The specific locations of changes in the rule made during the First Notice Period are submitted in the form required by Section 220.600 of the JCAR rules and are shown in Attachment A of this Second Notice.
- 5) The Agency received notification from the Office of the Secretary of State, Administrative Code Division that they had reviewed the Proposed Rule and found that it complied with codification requirements.
- 6) The Proposed Rule does not contain incorporations by reference pursuant to Section 100/5-75 of the Illinois Administrative Procedure Act.
- 7) The Agency did not receive any comments regarding this rulemaking from businesses identifying themselves as small businesses pursuant to Section 100/5-40(c) of the IAPA. Therefore, a Final Regulatory Flexibility Analysis was not prepared.

- 8) In order to comply with the requirements of Section 100/5-30 of the Administrative Procedure Act and 1 Ill. Adm. Code 220/285, the Agency provided a copy of the proposed amendments to members of the affected community through the Agency's website.
- 9) The Agency is proposing Rule 29 IAC 120 to establish the criteria for the issuance of State grants to not-for-profit organizations at High Risk of threats, attacks, and acts of terrorism. The grants shall be used to assist the not-for-profit organizations in preventing, preparing for, or responding to acts of terrorism. This Part will establish application requirements, procedures for submission of grant applications, and the issuance of grant funds.
- 10) The Agency received several comments during the First Notice Period regarding this proposed Rule. A copy of the comments and the Agency's responses to those comments are shown in Attachment B and C to this Second Notice.

- 12) The Joint Committee on Administrative Rules requested the Agency complete a State Mandates Act Questionnaire and it is attached.

- 14) This Amendment does not require the use of any forms for compliance.
