- Continued discussion of AFN Advisory Committee's involvement in the drafting and revision process of Illinois' Emergency Operations Plan (EOP).
 - Scott Gauvin shared an overview of the proposed plan to draft the Illinois Emergency Operations Plan. Highlights are;
 - The drafting process will be a 3-year timeline.
 - As different sections are completed, the sections will be shared with AFN Committee for review and recommendations.
 - The Committee discussed the possibility of how the AFN Committee can be involved earlier in the process, ie: being part of the initial drafting team, or being able to provide input during the initial drafting process.
 - Scott G shared that the drafting team process occurs over time. The drafting team may not meet in person and much of the work may be done remotely.
 - The Committee asked for the possibility of having AFN members join the drafting team. Scott G stated this is possible and is open to discuss further to see how it can be done within regulations.
 - Per request of Kira Meskin Schiff, Scott G agreed to provide the whole AFN Committee with a document that explains the intended plan for revising Illinois' Emergency Operations Plan as well as the Committee's anticipated involvement in the process.
